

Section 3 – External Auditor’s Report and Certificate 2023/24

In respect of **Chichester Harbour Conservancy - OT0010**

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2024; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

2 External auditor’s limited assurance opinion 2023/24

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Section 1, Assertion 2 has been incorrectly completed. Information received from the internal auditor highlights the fact that the authority has not followed its own internal procedures in respect of the fixed asset register, noting that responsibilities in respect of the fixed asset register are unclear and there are inconsistencies in the quality of recording and checks. This is consistent with the Internal Auditor’s response to Internal Control Objective H in the Annual Internal Audit Report. As a result, this assertion should have been answered ‘No’. The authority has confirmed that this matter is being addressed in the current year. If as a result of the review being undertaken any assets are found to be out of date or incorrectly recorded the authority should ensure that the relevant adjustments are made to Box 9 of next year’s AGAR and that the prior year figure is restated if appropriate.
